Question #5: Does SWEPCO have interest in seeing Operations and Maintenance (O&M) services proposals from Bidders?

Answer: As per Section 9.1.9 of the RFP, the proposal Bid Price shall not be contingent upon an operations and/or maintenance agreement with the Bidder, however, SWEPCO would entertain an O&M proposal if it is separate and not included in, or contingent on, the Bid Price.
